Dear Supplier,

As part of a simplification of the group legal structure, and our strategy to operate under one trading name, our legal entity will be changing from Cooper Group Ltd to **Inchcape Retail Ltd**, and we are **rebranding** the Cooper Group businesses at Cobham, Chelmsford, Colchester, Ipswich, Norwich and Reading to '**Inchcape**'.
